Caretaker's Report (Jake Payne)

Security - Weekly and random walk-arounds and security checks completed. Five hunters / shooting reports investigated.

Water – Performed routine monitoring, meter readings, water charting, static testing, monthly water sampling, and tank level monitoring. Submitted reports to DOH, updated DSL system chart. Continued to study for Water exam. Replaced hydrant in garden area. Started on the 2017 Consumer Confidence Report.

Maintenance – Cleaned shop & clubhouse, picked up garbage around community and CRR entrance off of 410, filled potholes by mail boxes, participated in Community Clean-up day, cut and stacked multiple trees that came down during winter storms. Trial cleaning will start next week.

Office / Admin – Updated database, organized office. Five clubhouse reservations have been made for 2017 / 2018 season. Prepared and sent out meeting minutes, voting ballots for open Board positions, fire letter and end-of-year dues notices.

Commission Reports

Water & Facilities (Karl Goeres)

Valves have been inventoried. Replacement of old valves will start this summer. Walkways around the community center need to be repaired / replaced. Contractors will be contacted to provide bids. Structure at the picnic area at the south end of CRR is starting to collapse so it will be dismantled. A new truck was purchased to replace the 20 year old truck that had increasing maintenance problems.

Architectural Control (Jake Payne). 14 permits issued over the last 12 months for building of structures and removing of danger trees.

Shoreline Stabilization and Conservation Commission (Diane Thompson)

The River Committee will arrange with Lawrence Dominguez, Senior Ecologist with engineering firm KPFF for annual measurements of erosion. This can be done as needed as the river changes. Summary of river project can be found on the CRR website under the shoreline tab http://crystalriverranch.org/shoreline-erosion/. Monthly reports will be provided as needed.

Horse Stables (Wendy Starrett) Two full time horses and one short term horse are in the stable. Many improvements were made over the past year to keep runs free of mud.

Old Business

Unsafe Recreational Shooting - The Snoqualmie Ranger District is requesting comments on the proposed Snoquera Landscape Analysis project, which includes decommissioning target shooting at the 7013 area. The Forest Service is proposing the closure of this area. Danger Trees in Common Area - There was a short discussion regarding how to deal with potential danger trees in common areas. The Board is evaluating options. If there are any danger trees on lot owner property, the owner can obtain a permit from the ACC for tree removal.
